FVSU	\$ 2,083,220	\$ 1,940,083	2,311	2,223	<p>Upon receipt of the Grant Award Notification (GANS) from the Department of Education, Fort Valley State University (FVSU) promptly made available emergency financial aid grants as funded by the Coronavirus Aid, Relief, and Economic Security (CARES) Act directly to students enrolled in the spring 2020 semester for their expenses related to the disruption of campus operations due to COVID 19, (including eligible expenses under a student's cost of attendance such as food, housing, course materials, technology, health care, and child care) as required by Section 18004(c) of the CARES Act.</p> <p>As of March 13, 2020, students must be eligible to participate in Title IV program under Section 484 of the Higher Education Act of 1965, as amended (HEA). For purposes of disbursement of these funds, students 2019-2020 Free Application for Federal Student Aid (FAFSA) was used to determine eligibility.</p> <p>FVSU awarded student emergency grants on the basis of need (established by expected family contribution (EFC)). FVSU allocated emergency grant awards to students across multiple tiers. Bounds of tiers are defined by the Expected Family Contribution (EFC) as determined by the 2019-20 FAFSA.</p>
